Fall 2020 Admissions COVID-19 Plans from Michigan's Four-Year Universities and Colleges

Michigan's public and independent non-profit four-year colleges and universities are taking steps to meet the needs of high school seniors as they prepare to enter college in the fall, despite the extraordinary circumstances of COVID-19 and its impact on students and families.

If you have already been admitted, congratulations! All colleges and universities are still open and will be open this fall, although details are still being worked on. We look forward to returning to normal, in-person classes as quickly as is safely possible.

However, if you have not yet applied or committed to a college or university, it's not too late to make the decision to attend college in Michigan.

Our first priority is contributing to the efforts to bolster the health and safety of our communities. But we are also supporting Michigan's high school students as they maintain hope about their future, and continue to pursue their collegiate goals. Each campus is here to help students and their families navigate undergraduate admissions during these challenging times.

Our four-year institutions are coordinating across sectors and with community colleges and K-12 schools to help students make good decisions that ensure they are successful in reaching their education and career goals.

While the impact of COVID-19 on students, families and institutions is fluid, at present we are planning for fall 2020 admissions by:

- Recognizing that while students must satisfy high school graduation requirements and meet minimum college
 admission requirements for freshmen, <u>our institutions will not disadvantage 2020 fall applicants due to the</u>
 <u>pandemic's effects on education delivery</u>. Each of our universities will be flexible and accommodating of students to
 the extent possible.
- Moving all activities related to admitted student programs, transfer advising, prospective student events and campus visitations to a virtual experience/platform, or cancelling events where we cannot safely offer them inperson or effectively online.
- Providing flexibility in admissions processes to ease, to the extent possible, the disruption for fall 2020 applicants.
 Each university or college has institutional websites dedicated to COVID-19 information, including details about fall 2020 admission decisions and deadlines.

We are committed to communicating, collaborating, and engaging with students, families, and schools now for the Class of 2020 and in the future as we identify impacts to the Classes of 2021 and 2022.
